

## COVID-19 UPDATE THE PLAZA'S TIER 3 REOPENING STRATEGY

Effective March 15, 2021

As The State of Hawaii's COVID-19 case count continues to decline and vaccinations amongst the general population continue to rise, The Plaza Assisted Living, in line with the City and County of Honolulu's Reopening Plan, will move toward modified restrictions for Residents and Families.

Effective March 15, 2021 all Plaza communities will operate under The Plaza's Tier 3 Reopening Strategy. It is our hope that as we progress in the fight against COVID-19, we will be able to further loosen restrictions as the City and County of Honolulu graduates to its Tier 4 Reopening Phase.

## VISITATIONS

One guest (over the age of 13), per resident, per day, will be allowed to visit with the resident in their apartment or a specified area within the community. If the resident resides in a shared apartment with a roommate, and a separate space outside their apartment cannot be provided, their bedroom door must remain closed for the duration of their visit.

Other visitation guidelines include:

- All visits must be scheduled during designated hours, please contact community for details
- Guest and resident must keep their masks on at all times during, eating and drinking will continue to be prohibited
- Visitors will not be allowed access to common areas, including restrooms and the bistro
- For those residents who have not completed their COVID-19 vaccine, it is highly recommended that outdoor only visitations occur
- Pets will be welcomed for both indoor and outdoor visits
- Telehealth appointments will not count toward a resident's daily visit
- Guest must pass all entrance screening questions and be symptom free. Please do not come to the community if you are experiencing any symptoms or signs of illness within the last 24 hours.
- Outdoor, window and virtual visits will continue by appointment only.
- Visitation restrictions do not include those visiting for an end of life circumstance.

## **RESIDENT EGRESS AND INGRESS**

Residents leaving the community for both essential and non-essential activities <u>will not</u> be asked to quarantine upon their return as long as they <u>do not</u> engage in the activities and



behaviors, noted below. The Plaza has deemed certain activities and behaviors as risky, and engaging in such will still require a 14-day quarantine in the resident's apartment.

- Any overnight stay
- Any travel off island
- Contact with anyone who has traveled outside of Hawaii in the past 14 days
  Outdoor visits with pre-travel test okay
- Removal of mask while out for any reason. Resident should keep their mask on at all times including when riding in a car with others.
- Eating out of the community at a restaurant or private home, as this would mean the resident's mask did not remain on at all times.

Residents <u>can</u> participate in or visit the following without quarantine as long as their mask remains on, at all times:

- Gatherings of <10 people
- Funerals of <25 people
- Gym/Fitness Center
- o Concert, performance, sporting event, theatre

The Plaza will continue to prioritize keeping our residents and team members safe. Sanitizing protocols will continue to be followed.

We are excited that most of the residents will complete their vaccinations by March 15, 2021. At this time, out of an abundance of caution, we will not be altering our protocols based on whether an individual is vaccinated or not. If you have any questions please contact the Administrator.
